Purchases of tax credits with face values between \$10,000 and \$20,000 will have an additional 3% added to the going rate of tax credit sales. For example, if \$15,000 of credits were purchased in September 2011, the cost would equal 87% + 3% for a purchase price of 90% of face value.

**NOTE:** Credits will be matched on a registration basis; therefore, the earlier you register, the better are the chances you will get credits at your discount and timing preferences.
